Statutory Consultation

WESTMORLAND AND FURNESS COUNCIL (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF SPEED LIMITS) (ORDER 2024) VARIATION ORDER NO.1 20><

Following requests from Town and Parish Councils, the local Council Members, and from feedback received during initial consultations in relation to vehicle speeds, Westmorland and Furness Council are proposing changes to the speed limit at various locations across the South Lakeland area.

Officers found that improvements can be made to speed limits to enhance road safety at the following four locations:

- 1. Grayrigg, A685 Kendal to Tebay road (Longtail Brow) a proposed extension to an existing 30mph speed limit,
- 2. Grange-over-Sands, C5043 Grange Fell Road a proposed extension to an existing 30mph speed limit,
- 3. Hutton Roof, C5087 From the C5085 to U5414 via Hutton Roof a proposed new 30mph speed limit on a presently unrestricted length of road,
- 4. A6, Milnthorpe to Levens: Proposed extension of the existing 50mph speed limit, including C5072, Leasgill. From the centre of its junction with A6 Princes Way, Levens Park.

During this statutory consultation period, we have the flexibility to make the proposals less restrictive but not more so. Therefore, we are currently proceeding with the restrictions and locations as outlined in the accompanying plans. Unfortunately, any requests for alternative restrictions or additions cannot be accommodated at this stage. However, these requests can be noted for potential consideration in future schemes. Following advertising and consultation on the proposals, a report will be prepared to go before the Locality Board for the South Lakeland area, scheduled for 29/01/2025. The Locality Board, comprising of Councillors, will consider all the responses received during the consultation period and make the final decisions as to what will be implemented. We will endeavor to inform you of the committee decision in due course. If the Locality Board agree to implement the proposals, the making of the Traffic Order and the placing of signs and markings should take place within a 4 to 6 month period after the decision.

Statement of Reasons

Following requests from Town and Parish Councils, the local Council Members, and initial consultations in relation to speeding traffic, Westmorland and Furness Officers have undertaken the relevant assessments in line with the Department for Transport "Setting Local Speed Limits" guidance. Officers found that further improvements can be made to speed limits within the local area to improve road safety at a total of 4 locations.

- 1. Grayrigg, A685 Kendal to Tebay road (Longtail Brow) a proposed extension to an existing 30mph speed limit,
- 2. Grange-over-Sands, C5042 Grange Fell Road a proposed extension to an existing 30mph speed limit,
- 3. Hutton Roof, C5087 From the C5085 to U5414 via Hutton Roof a proposed new 30mph speed limit on a presently unrestricted length of road,
- 4. A6, Milnthorpe to Levens: Proposed extension of the existing 50mph speed limit, including C5072, Leasgill. From the centre of its junction with A6 Princes Way, Levens Park.

Therefore, Westmorland and Furness Council proposes to make the above order in discharge of its duty under Section 122 of the Road Traffic Regulation Act 1984, 'to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians)' and considers that it is expedient to make the above order for the following reasons set out in Section 1(1) Road Traffic Regulation Act 1984:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising,
- (f) for preserving or improving the amenities of the area through which the road runs.

Westmorland and Furness Council hereby gives notice that it proposes to make the above Order under Sections 82, 83 and 84 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the Act
- 2. The effect of the proposed Order will be to amend the speed limits to enhance road safety at the following locations:
 - a. Grayrigg, A685 Kendal to Tebay Road (Longtail Brow): Proposed extension of the existing 30mph speed limit.
 - b. Grange-over-Sands, C5042 Grange Fell Road: Proposed extension of the existing 30mph speed limit.
 - c. Hutton Roof, C5087 from the C5085 to U5414 via Hutton Roof: Proposed new 30mph speed limit on a currently unrestricted road.
 - d. A6, Milnthorpe to Levens: Proposed extension of the existing 50mph speed limit, including C5072, Leasgill. From the centre of its junction with A6 Princes Way, Levens Park.

Westmorland and Furness Council, in exercise of its powers under Sections 82, 83, and 84 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. Commencement and Citation

- (1) This Order shall come into operation on [XX 20XX] and may be cited as the Westmorland and Furness Council (Various Roads, South Lakeland Area) (Consolidation and Provision of Speed Limits) (Order 2024) Variation No. 1 202x.
- (2) In this Order, the expression 'the 2024 Order' means the Westmorland and Furness Council (Various Roads, South Lakeland Area) (Consolidation and Provision of Speed Limits) Order 2024.
- (3) The provisions of any other Order Byelaw or enactment relating to the speed restrictions on the lengths of road specified in the Schedules hereto and not specifically referred to in this Order are hereby revoked and the provisions of this Order shall prevail for all purposes.
- (4) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (5) No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- (6) In accordance with Section 87 of the Act, no speed limit imposed by this Order shall apply to any vehicle on an occasion when it is being used for fire brigade, ambulance, or police purposes, if the observance of that speed limit would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.

2. Revocations to the 2024 Order

(1) The provisions of the 2024 Order are hereby revoked as specified in Schedule 1 to this Order.

3. Speed Limits Insertions to the 2024 Order

Lengths of road subject to 30 mph speed limit

(1) Schedule 2 of the 2024 Order is hereby varied by the insertion of the items, in the appropriate place, as set out in Schedule 2 to this Order.

Lengths of road subject to 50 mph speed limit

(2) Schedule 4 of the 2024 Order is hereby varied by the insertion of the items, in the appropriate place, as set out in Schedule 3 to this Order.

C5087 from the C5085 to U5414 via Hutton Roof

From its junction with C5085 east of Mealrigg, in a northerly direction to a point 16 metres from the centre of its junction with U5411 by St John's Church at Hutton Roof.






South Lakes Speed Order Variation No.01 Location 1 Grayrigg Extension of 30mph Speed Limit






South Lakes Speed Order Variation No.01
