

WESTMORLAND AND FURNESS COUNCIL (VARIOUS TOWNS AND VILLAGES IN
THE EDEN LOCALITY AREA) (CONSOLIDATION AND PROVISION OF SPEED
LIMITS) ORDER 2023

1. Westmorland and Furness Council hereby give notice that it proposes to make the above Order under Section 84 of the Road Traffic Regulation Act 1984.
2. The effect of the proposed Order will be to consolidate (and as appropriate amend) the provisions of The County of Cumbria (Various Towns and Villages in the District of Eden) (Consolidation and Provision of Speed Limits) Order 2023 and the following proposals, into one concise order: -
